



EXHIBITORS AGREEMENT 2017 Showcase of Homes Expo

Exhibitor desires to lease an 8' table space at the 2017 Showcase of Homes Expo and Kickoff Luncheon ("Expo") to be held at the Chattanooga Convention and Trade Center ("Trade Center") on September 21st, 2017 by completing this Exhibitors Agreement ("Agreement").

Exhibitor and HBAGC agree as follows:

1. **Request for Space.** Exhibitor hereby requests that the HBAGC grant to exhibitor a lease for table space at the Trade Center for the Expo in accordance with the terms and conditions of this Agreement.

*Tables will NOT be supplied with drapes or skirting. You must supply your own table skirting. Two chairs will be available for all exhibitors.

4. **Full Payment.** In order to reserve a space in the Expo, Exhibitor shall pay Three Hundred and 00/100 Dollars (\$300.00) for one table, **no later than September 8, 2017**. Additional tables can be purchased for Two Hundred and 00/100 Dollars each. All payments are non-refundable.

5. **Liabilities.** HBAGC does not make any warranty or guaranty to exhibitors against loss or damage or any kind. All expo space is leased at the risk of the exhibitor and the exhibitor agrees to release, indemnify and hold harmless the following parties from any and all the liability from any cause related in any way to the show: HBAGC, its employees, agents, volunteers, officers, directors and members; The City of Chattanooga; The Carter Street Corporation and Hamilton County (all of whom are collectively referred to below as the "Home Show Parties"). None of the Home Show Parties shall be held responsible by exhibitor, in any manner whatsoever, for any loss, damage or injury that may occur to the exhibitor, employee, guests or property from any cause whatsoever prior to, during, or subsequent to, the show for any loss, damage or injury related in any way to the expo or exhibitor's participation in the expo.

6. **Limitations.** Exhibits shall be installed so that they will not exceed beyond the table space allotted. **Distribution of printed materials, souvenirs or other articles must be restricted to the table space of the exhibit.**

7. **Amendments.** Any and all matters of questions not specifically covered by the preceding rules and regulations shall be subject solely to the decisions of HBAGC management or Showcase of Homes officials. All amendments so made shall be binding on exhibitors equally with the foregoing rules and regulations.

8. **Damages.** Exhibitors are liable for any and all damages caused to the building floors, walls, or columns, or standard booth equipment and to other exhibitor's property.

9. **Compliance.** HBAGC reserves the rights to reject, eject, or prohibit any exhibit in whole or part, or any exhibitor or his representatives, with or without giving cause. If an exhibit or exhibitor is ejected for violation of these rules or for any other reason, no return of rental monies shall be made.

I/We hereby agree to all items set forth in this Agreement, as well as all items set forth in the Rules and Regulations made a part of this Agreement. I/We agree further to pay the HBAGC for the table space rented in accordance with the payment schedule set forth in the Rules and Regulations. I/We have sent the deposit payment with this Agreement.
